The following is prioritized:

<u>Project Description</u>: The proposed school health consultation is designed to guide and support South Kingstown Schools in the delivery of health services in the school environment (including screenings). This guidance would include:

- consultations;
- meeting with nursing staff annually and prn
- provide medical/professional knowledge to administration
- furnishing information on health-related matters;
- review of standing orders, protocols and procedures;
- serve as a liaison with students' physicians
- initiating first-aid orders
- and reporting and management of infectious diseases and outbreaks, in

accordance with the most current Department of Health recommendations related to infection control in the school environment.

Requirements:

• license to practice allopathic or osteopathic medicine in Rhode Island in accordance with Chapter 5-37 of the RIGL

• have knowledge of all state and local laws, regulations and protocols affecting schools and participate to ensure implementation of all such laws, regulations and protocols in collaboration with the school's administrative authorities and school health personnel.
